It is usually advisable for the client to select multiple name options, as the name reservation process allows three options for a single fee. Submitting names one at a time results in multiple name reservation fees. It is possible to incorporate a company without first reserving a name by using its incorporation number with "BC Ltd." as its name and then implementing a name change at a later date. Also conduct a broad Internet search to see if there are existing similar business names or trademarks which may result in the proposed name being rejected or cause future intellectual property issues for the client. As this can be a complicated process, it may also require consultation with a tax lawyer. If the share structure involves multiple classes of shares, the special rights and restrictions attached to those classes of shares will be set out in the Articles. A set of standard Articles is set out in Table 1 of the BCA Regulation and those can be adopted as the company's Articles.
